

Play Your Part Lottery – Terms and Conditions



1. Lottery entrants [also referred to hereafter as 'donors'] agree to be bound by these rules.
2. This lottery is being promoted by and on behalf of the **Belgrade Theatre Trust (Coventry) Limited** [also referred to hereafter as 'the Belgrade']. Monies raised by this lottery will support the work of the Belgrade, Registered Charity No 219163.
3. For the purpose of the Gambling Act 2005, this lottery is defined as a 'Society Lottery.'
4. This lottery is run under the licence held by the Belgrade Theatre Trust (Coventry) Limited.
5. To enter the lottery, you must be a resident in mainland Great Britain and aged 16 (sixteen) or over.
6. The monthly prize is 20% of the total lottery pot for the month entered and minimum win of £20 guaranteed.
7. When the cash prize is awarded, this will be made by cheque in the name of the entrant only.
8. Each lottery entry costs £5 and proceeds are in support of the Belgrade's **2020 Redevelopment Project**.
9. All lottery entry sales are final and no refunds shall be made at any time. All entrants acknowledge that their payment of £5 per chance to enter the lottery does not guarantee that they will win any prize.
10. The draw will take place on the first day of the subsequent month and the winner will be notified within 7 days except on bank holidays when the draw will be made on the subsequent working day. You do not need to be present at the draw to win the lottery.
11. Full payment for each entry must be received either in the form of cash or cleared funds before that entry can be included in the draw. Only entries for which full payment has been received are eligible to win the prize.
12. All entrants are solely responsible for providing the Belgrade with their accurate and up-to-date contact details and the Belgrade will be in no way liable for any failure or inability to contact any entrant due to any errors, omissions or inaccuracies in the contact details that the entrant has provided. In the event that an entrant changes their contact details, they will be solely responsible for advising the Belgrade of the change. Prizes which we cannot deliver because we do not have accurate details, no response from the winner within 7 days or which remain uncashed will go to supporting the work of the Belgrade Theatre.
13. By accepting the prize, the winning entrant agrees to take part in promotional activity and the Belgrade reserves the right to use the name of the winner, their photograph and audio and/or visual recordings of them in any publicity.
14. The Belgrade Theatre Trust (Coventry) Limited shall not be liable to lottery entrants for any loss or damage suffered or arising from any delays or failures in:
 - o the postal service or other delivery methods used by the Belgrade or the entrant from time to time;
 - o any software or other systems used by the Belgrade or for the administration of the lottery;
 - o the Banking system used by the Belgrade or the entrant;
 - o entering a chance into the draw; or
 - o any event beyond the reasonable control of the Belgrade.
15. The Belgrade Theatre Trust (Coventry) Limited is committed to protecting privacy. Data that is collected from a lottery entrant is used lawfully in accordance with the Data Protection Act 1998 and is used for the purpose of processing lottery chances, subsequent entry into the lottery draw, and informing winners that they have won a prize. The Belgrade may also contact entrants about other aspects of its fundraising work.
16. In the event of any dispute regarding the rules, the decision of the Belgrade Theatre Trust (Coventry) Limited shall be final and no correspondence or discussion shall be entered into.
17. The Belgrade Theatre Trust (Coventry) Limited reserves the right to amend these rules at any time. If the Belgrade does this, it will publish the amended rules on its website.
18. The Belgrade reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of these rules.
19. The Belgrade shall not be liable to entrants in contract, tort, negligence or otherwise for any indirect or consequential loss suffered by the entrant in relation to participating in the Lottery (including loss of the opportunity to enter the Lottery and / or the chance of winning a prize).

21. The Laws of England and Wales shall govern the interpretation and/or enforcement of these Terms and Conditions and the Belgrade Theatre Trust (Coventry) Limited and all entrants hereby submit to the exclusive jurisdiction of the English courts.
22. Employees of the Belgrade Theatre Trust (Coventry) Limited - who work directly on the production of the lottery (and members of their households) - are ineligible to enter this lottery. Any entries bought in the name of such Belgrade employees or members of their households will be rejected from the draw and considered as donations to the work of the Belgrade Theatre Trust (Coventry) Limited.
